- b. Review by-laws
 - 1. First item on Page 2 of the by-laws under membership. Kristie asked if it makes sense to have someone sub in for just one meeting? There could possibly be some restructuring in the future, background knowledge is very helpful when making decisions.  - 2. The second item under meetings, letter G. There was discussion about whether we should leave this item in the by-laws. It was decided to leave this in the by-laws and information regarding meeting times will be put in the bulletin, this will happen a couple of weeks prior to the meeting. - c. Invitation prayer before mass Herman noted that there was confusion as to what parishes are included in the ACC in a mass that he attended. Herman asked if we should provide some education to parish members, possibly do this before masses. Father Dan noted that he prefers that we don't have a prayer/announcement before mass, he noted that this is a time for preparation for the mass.
